As the only federal PAC that represents the entire real estate finance industry, MORPAC allows us to send a strong, collective and clear message to key policymakers.



Contributions to morpac are not tax deductible for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose Contributions exceed \$200 in a calendar year. Contributions to morpac are used to support candidates to federal office. All contributions to morpac are voluntary. You may refuse to contribute without reprisal. MORPAC CHAIR LETTER

While no formal announcement was conveyed, MORPAC paused its typically aggressive level of fundraising activities in mid-March, outside of maintaining recurring contributions via payroll deductions and monthly/ quarterly credit card contributions. Consequently, and despite an incredibly strong first quarter, our current MORPAC fundraising totals are predictably behind the pace of our 2019 and 2018 efforts.

In June, MORPAC hosted a successful Action Week (June 15–19), the official kick-off event for MORPAC fundraising efforts. 8 professional organizations participated, recruiting 400 donors who contributed or pledged to MORPAC, and raising more than \$350,000 (collected/pledged), bringing our mid-year 2020 fundraising total to roughly \$650,000.

MORPAC is the only PAC that directly represents the interests of the entire real estate finance industry. MORPAC helps to build and maintain relationships between industry and legislators and it's important that we stay at the forefront of issues critical to your business and your communities. It is funded entirely through voluntary contributions from eligible industry professionals.

So far during the current 2019–20 election cycle, MORPAC has raised nearly \$1.8 million from grassroots individual donors, has contributed over \$1.7 million to federal candidates and party committees, and has maintained its national "top 20" ranking among trade association PACs.

The 2020 elections will undoubtedly have a significant impact on our industry. As such, it is critical that MBA continues to leverage MORPAC to engage key policymakers while they actively consider and pass legislation impacting our member's businesses and customers.

We are pleased to share our 2020 MORPAC Mid-Year Report that details our campaign's progress through June 30, 2020. As a show of gratitude to our dedicated contributors, this report lists all the individuals and companies who have been a part of our 2020 campaign cycle, including those who participated during MORPAC Action Week. We've also highlighted policy wins our political programs helped advance, and our MORPAC Speaker Series, a donor benefit program offered exclusively to MORPAC supporters.

We hope that you will see the great steps we are taking with our PAC and on our legislative and political priorities. None of this is possible without your active involvement and your continued support is imperative to our success. Now is the time to engage!





MORTGAGE ACTION ALLIANCE

ADVOCACY WINS

This year's policy and advocacy successes are instrumental and demonstrate MBA's ability to lead, even during great change. MBA advocacy leads our members in thoughtful ways with meaningful impact, as noted below.



COVID-19 Pandemic Response Policy Wins

- Successful implementation of origination flexibilities

 such as alternatives to traditional appraisals
 and verbal verification of employment across
 agencies and investors to help lenders serve
 borrowers during the COVID-19 pandemic.
- Successfully advocated for remote work options for MLOs and others working for state licensed IMBs. MBA urged state regulators to obtain written guidance for mortgage loan originators and others to work from home in states where they are required to work from a licensed office or branch. MBA also advocated with state policy makers to add financial services to "essential worker" authorizations.
- Advocated for alignment between state COVIDrelated legislation and the CARES Act. MBA worked with its partner state and local associations nationwide to address the challenge of coronavirus relief legislation that sought to go well beyond the mandates for residential, commercial, and multifamily forbearance in the federal CARES Act. In New York and Washington, DC, MBA led efforts to successfully amend legislation to align state compliance with federal requirements, and to defeat the most extreme of these policy proposals in California.
- Implementation of policies and programs supporting servicer liquidity during the period of high forbearance rates due to the COVID-19 crisis, including broad bipartisan, bicameral support in Congress, Ginnie Mae's PTAP program and the 4-month limit on servicer advance obligation from the GSEs.

- Obtained policy changes from FHA, CFPB and FHFA to improve post-forbearance options for borrowers and servicers including:
 - + helping borrowers that have exited forbearance obtain financing without long waiting periods
 - + providing streamlined forbearance exits by allowing borrowers to defer forborne payments to the end the loan term without a loan modification
 - + waiver of costly FHA QC requirements on loans in forbearance, and
 - + relief from delinquency triggers in GSE, FHA and Ginnie Mae eligibility standards
- Led joint trades requests for life company accounting and risk-based capital relief for loans modified to address temporary impacts of the pandemic. The National Association of Insurance Commissioners (NAIC) granted the requested accounting relief and provided capital reporting relief for loan modifications that occur during 2020.
- Secured important clarification from the OCC and FDIC via an industry coalition that the Troubled Debt Restructuring (TDR) relief provided by the federal prudential regulators in a March Interagency Statement and in the CARES Act relates to lending arrangements with non-bank lenders, including warehouse lines of credit and repurchase agreements.
- Successfully advocated for the Federal Reserve's revisions to the Term Asset-Backed Securities Loan Facility (TALF) program to extend eligibility to seasoned AAA CMBS as collateral.

ADVOCACY WINS CONTINUED

Other Policy Wins

- Enactment of Remote Online Notarization (RON) in 26 states – 25 of which align with the MBA model bill for state laws. MBA also achieved bipartisan, bicameral introduction of legislation to enable the use of nationwide use of RON.
- Reduction in False Claims Act risk for FHA lenders as a result of revised program certifications and defect taxonomy.
- Expansion of FHA's CWCOT program eligibility, increasing the use of direct conveyance and improving the bid process.
- Successfully advocated for changes to OCC's final revised CRA rule to provide full credit for mortgage banking activities. The proposed rule would have provided only partial credit for mortgage banking.
- MBA worked closely with a broad range of member firms and led the effort with trade groups and policymakers -including the IRS, Treasury Department, FHFA, the GSEs, and Congress- to obtain muchneeded clarification from the IRS regarding the effective date for Section 2202 of the Tax Cuts and Jobs Act, which granted certainty to market participants that seasoned loans and loans that were in the pipeline with transcript information received from the IRS prior to December 28 were never intended to be covered by the new consent requirement, ensuring liquidity in those markets.






- Achieved long-advocated process reforms from CFPB that will help reduce "regulation by enforcement." The Bureau has announced an advisory opinion program, no action letter program and trial disclosure program to better help regulated entities understand their obligations and end the practice of regulation by enforcement. MBA pushed for these specific changes and other process reforms in our Roadmap to CFPB 2.0.
- In April, response to MBA advocacy, the CFPB issued a final rule that increased the threshold for HMDA reporting from 25 to 100 loans in each of the two preceding years- which effectively exempts many of MBA's multifamily members-and that permits affected lenders to stop reporting activity.

MBA ADVOCACY: WORKING FOR YOU

We continue to work closely with policymakers and stakeholders on a variety of issues affecting you, your customers, and the entire real estate market.



COVID-19 Pandemic Response Legislative Progress on Key Issues

- Improving the processes to implement forbearance requirements for COVID-affected borrowers, including advancing legislation that would compel FHA to insure loans in forbearance and the GSEs to purchase loans (regardless of mortgage type) without any punitive pricing.
- MBA continues to urge Congress to clarify that Section 4022 of the CARES Act applies over the same covered period as the related section 4023 of the CARES Act.

Legislative Progress on Other Issues

- Promoting legislation that would provide the federal government with new tools to encourage localities to remove regulatory barriers to housing affordability.
- Promoting bipartisan, bicameral legislation, which would offer tax credits to attract private investment for building and rehabilitating owner-occupied homes, creating a pathway to neighborhood stability through sustainable homeownership.
- Ensuring adequate federal funding to modernize FHA's antiquated IT infrastructure.
- Advancing legislation that would preventing the use of Fannie/Freddie guaranty fees to pay for non-housing related federal programs.
