As the only federal PAC that represents the entire real estate finance industry, MORPAC allows us to send a strong, collective and clear message to key policymakers.



Contributions to morpac are not tax deductible for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose Contributions exceed \$200 in a calendar year. Contributions to morpac are used to support candidates to federal office. All contributions to morpac are voluntary. You may refuse to contribute without reprisal. The guidelines mentioned Are merely suggestions. You are free to contribute more or less than the guidelines suggested and mba will not favor nor disadvantage you by reason of the amount of your contribution or your decision not to contribute.

## MORPAC CHAIR LETTER

MORPAC, MBA's political action committee (PAC), is ranked in the top 20 nationally among trade association PACs, in both fundraising and contributions to federal candidates. MORPAC raised over \$1.1 million in individual donations in 2019 — a haul that puts us on track to reach our 2020 cycle fundraising goal of \$2.25 million.

We are pleased to share our 2019 MORPAC Year-End Report that details our campaign's progress since January 1, 2019. As a show of gratitude to our dedicated contributors, this report lists all the individuals and companies who have been a part of our 2019 campaign. We've also highlighted policy wins our political programs helped advance this year.

In 2019, MORPAC recruited 497 new contributors, raising over \$300,000 in new dollars. 20 companies ran a MORPAC campaign in 2019, including 12 professional organizations during MORPAC Action Week.

We also launched the MBA Advocacy Roadshow, a key tactic within a larger MBA strategic initiative to increase lobbying effectiveness, and to help member companies and partner associations cultivate organizational cultures that prioritize employee and volunteer leader engagement in industry advocacy. The goal is to help advocates launch advocacy campaigns within their companies and state/local associations, and to expand MBA's grassroots network of supporters in key states and congressional districts.

MORPAC is an essential advocacy tool that allows us to build and strengthen our political clout among key elected officials in both congressional chambers and across the political spectrum. MORPAC is funded entirely through voluntary contributions from people like you.

We hope that you will see the great steps we are taking with our PAC and on our legislative and political priorities. None of this is possible without your active involvement and your continued support is imperative to our success. Together, we can make a difference.

We appreciate and thank you for your dedication to MBA, MORPAC and our collective public policy goals.

# MORPAC 2019 STATS

AS OF DECEMBER 31, 2019

Since January 1, 2019, MORPAC has raised over **\$1.1 million** in hard dollars so far in the 2019-2020 election cycle — a haul that puts us on track to reach our cycle fundraising goal of **\$2.25 million**.

MORPAC hosted two individual fundraisers for Senate Banking Committee member Senator Mike Rounds (R-SD), raising **\$50,000** to benefit his re-election at MBA's Mid-Winter Conference, and **\$60,000** for the former Senate Majority Whip and key member of the Senate Finance Committee, Senator John Cornyn (R-TX), in conjunction with MBA's Annual Convention & Expo.

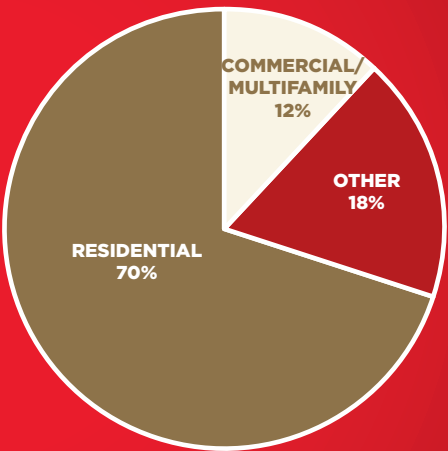

# SUSTAINED ADVOCACY DRIVES RESULTS

Active member engagement in MBA Advocacy helped send a strong, collective, and clear message on behalf of our industry to key policymakers and regulators resulting in positive progress and advocacy wins along the way.

- Secured passage of S. 1749, the Protecting Affordable Mortgages for Veterans Act of 2019. On the heels of MBA's National Advocacy Conference in April and a full-court MBA advocacy press on Capitol Hill, the bill was signed by President Donald Trump and enacted on July 25, 2019 (Public Law 116-33).
- Secured bipartisan, bicameral legislation to advance long-term reauthorization of the Terrorism Risk Insurance Act (TRIA), which was codified into law in the year-end \$1.4 trillion spending deal.
- Prevented inclusion of the Federal Housing Administration (FHA) transaction fee increase by securing \$20 million annually in House and Senate appropriated funds for FHA technology upgrades for fiscal year (FY) 2019 and FY 2020.
- Supported legislation in the House and Senate to prohibit the use of guarantee fees as an offset for non-housing-related federal spending.
- Secured the introduction of bipartisan, bicameral legislation to address Appendix Q and the challenges in documenting the ability to repay for borrowers with non-traditional forms of income.
- Prevented a lapse in the National Flood Insurance Program and continued to advocate for a long-term flood insurance reauthorization.
- Mitigated significant VA Home Loan fee increases from the Blue Water Navy Vietnam Veterans Act (Public Law 116-23).
- Contributed recommendations to Congress on the Financial Accounting Standards Board's CECL implementation, which led to bipartisan, bicameral legislation to study the overall impact of the standard and delay its enactment.
- Secured legislative reforms to automate the 4506T tax transcript process.
- Initiated legislative efforts in Senate and House on language that would allow licensed appraisers to become eligible to participate in FHA programs.
- Advocated for new funds for housing counseling and secured prohibition of funds used to seize mortgages via eminent domain in FY 2019 federal funding package; efforts continue for FY 2020.



Nathan Burch, CMB met with his Representative, Congresswoman Jennifer Wexton (D-VA), a freshman member of the House Financial Services Committee, to promote and advance key issues on behalf of the industry.

- Enacted remote online notarization (RON) legislation consistent with MBA principles in 12 additional states in 2019, bringing the total number of states that have enacted RON legislation to 22.
- Completed successful nationwide campaign to enact the required Dodd-Frank minimum standards for appraisal management companies.
- Helped defeat a harmful, first-in-the-nation licensing bill in Maryland that would have increased servicing costs without any substantive new protections or benefits for consumers.
- Released data-protection principles calling for uniform national guidelines to guide industry advocacy as state and federal policymakers respond to rising data security risks.

## BURTON C. WOOD LEGISLATIVE SERVICE AWARD WINNER

MBA presented its annual Burton C. Wood Legislative Service Award to California Mortgage Bankers Association (California MBA) CEO Susan Milazzo. The award is given annually to an MBA member employee in recognition of his or her sustained superior service to the association and the real estate finance industry as a whole. Milazzo was presented the award at MBA's 2019 Annual Convention & Expo in Austin, Texas.

Throughout her tenure since 2004 as California MBA's CEO, Milazzo has been a strong advocate for MBA and its political action programs. Milazzo has helped grow NAC, and consistently serves as a state leader for her delegation during the conference's "advocacy day" on Capitol Hill. Milazzo has also been a steadfast leader when advocating for California issues, including leading efforts on data privacy laws and defeating a recent rent control ballot initiative (Prop 10).

"Susan has dedicated her career to addressing the legislative and regulatory challenges facing our industry," said Brian Stoffers, CMB, 2020 MBA Chairman, and Global President, Debt & Structured Finance at CBRE. "She has been a strong advocate and leader for our industry, and I can think of nobody more deserving for this recognition. It is an honor to present her with this year's Burton C. Wood award."

The award is named after the late MBA Legislative Counsel Burton C. Wood, who devoted more than 30 years of service to MBA's advocacy efforts, and passed away in 2010. Wood was the first recipient of the award in 1990, and his lobbying skills gained the respect and attention of both Republicans and Democrats alike.

MORPAC awarded Mike Heagerty, CCMS, Principal & CFO, Gantry, with the 2019 Schumacher-Bolduc Award at the association's 2019 Annual Convention & Expo held in Austin, Texas. The award was given to Heagerty in recognition of his tireless work on behalf of MBA's political advocacy programs and the mortgage lending industry.

"The Schumacher-Bolduc Award is for individuals who exemplify MORPAC's mission and display commitment to expanding the reach of MBA's political advocacy efforts, and I can think of nobody more deserving of this honor than Mike," said Brian Stoffers, CMB, 2020 MBA Chairman, and Global President, Debt & Structured Finance at CBRE. "His dedication to nurturing MBA's political advocacy programs is unmatched, and that is reflected in his tireless commitment and success."

Heagerty is an active Mortgage Action Alliance (MAA) member, a MORPAC contributor, and regularly attends NAC. He leads an annual MAA enrollment campaign at Gantry and has an 85% participation rate among his employees. Heagerty also finds creative ways to promote MAA through his participation in several MBA policy committees/councils.

Outside of his political advocacy efforts, Heagerty was the 2019 Chairman of the Commercial Real Estate/Multifamily Finance Board of Governors (COMBOG) committee. During his tenure as Chairman, Heagerty consistently made MAA a priority in meetings and conference calls, and led the charge to achieve 100% COMBOG participation in MAA. Through his efforts, COMBOG yielded a record 98% participation rate.
